

# Modifying CRC or FPC Grant Award End Dates

**Purpose:** Use this document as a reference for how to modify or extend the End Date of a Cost Reimbursable Contract (CRC or As Incurred) or Fixed Price Contract (FPC) Grant Awards (also known as a No Cost Extension) in ctcLink.

**Audience:** Finance/Grant Fiscal Staff.

 You must have at least one of these local college managed security roles:

- ZC Awards Processing
- ZD Grants-Contracts Inq
- ZZ Awards Processing
- ZZ Grants-Contracts Reports

## Modifying CRC or FPC Grant Award End Dates

**Navigation:** Grants > Awards > Modify End Dates

 **Please Note:** In order to maintain balance between the Grant-side and Contract-side of an Award, the End Date must be updated on all four sets of tables; Contract lines, Associated Projects & Activities, Award Funding and Award Modifications. Once this process is completed, please submit a [Service Ticket](#) to request your project's End Date be updated in Commitment Control.

1. The **Modify End Dates** search page will display. Enter or look up the **Business Unit**.
2. Enter or look up the **Award ID** or **Project Number**.
3. Select **Search**.

4. The **Search Results** will display below. Select the **Results**.
5. The **Modify End Dates** page will display. Review the Award's five tables with listed **End Dates**.

6. For each section, select the individual checkbox(es) or the **'Select All Lines'** link to all the corresponding tables to update the End Dates:
  - a. Select the checkbox or **'Select All Lines'** link for **Contract Lines**.
  - b. Select the checkbox or **'Select All Projects/Activities'** link for all **Associated Projects & Activities**.
  - c. Select the checkbox or **'Select Funding Period'** link for **Award Funding**.
  - d. Select the checkbox or **'Select Modification Period'** link for **Award Modifications**.  
Optional to add the **Reference Award Number**.
  - e. Select the checkbox or **'Select Team Schedule'** link for **Project Team Members**.

- At the end of the page, in the **Copy End Dates** Section, enter or select the desired **New End Date, i.e. 09/30/2023**.
- Select the **Copy New End Date** button. Note the sections will update to the new end date.
- Select the **Save** button.

10. The Process Instance message window displays. Select the **OK** button.

11. In the **Associated Projects & Activities** section, select the **Commitment Control** tab.
12. Note the updated Project End Date(s) and the Commitment Control End Date is unchanged.

**i** Upon saving your page, the Contract Lines, Associated Projects & Activities, and Award Modifications will be updated to reflect the New End Date. However notice the Award Funding's date has remained the same. The Commitment Control End Date will need to be changed by SBCTC. You can check your commitment control dates by selecting the Commitment Control tab in the Associated Projects & Activities section of the page.
